AND WHEREAS JR Cousin Consultants Ltd., municipal engineers, have identified the land needed for the expansion works, which includes a portion of land located adjacent to the existing lagoon land to the west shown on the sketch attached to this Resolution ("lagoon expansion land".);

AND WHEREAS the lagoon expansion land is located within larger parcels of lands owned by the adjacent owner ("owner's lands");

AND WHEREAS the municipality has been working for a number of months on reaching an agreement to purchase the lagoon expansion land from the owner, with no agreement to purchase the lagoon expansion land being reached to date;

AND WHEREAS the timing for the lagoon expansion works is progressing to the point where the Municipality must now move forward with the acquisition of the lagoon expansion land either through an agreement with the owner or through expropriation if necessary;

THEREFORE BE IT RESOLVED THAT the Council of the Rural Municipality of La Broquerie made a final without prejudice offer to the owner to purchase the lagoon expansion land for \$160,000.00. This offer includes all of the owner's interests in the lagoon expansion land and any claim or impact on the owner and the remaining owner's lands arising from the acquiring of the lagoon expansion land and the proposed lagoon expansion. The offer shall be open for acceptance until September 26, 2014;

AND FURTHER BE IT RESOLVED THAT if the offer is accepted, the municipal solicitor is authorized to prepare a purchase agreement and the Reeve and the Chief Administrative Officer are authorized to execute the purchase agreement under the corporate seal of the Municipality, and any and all documents necessary to carry out the provisions of this resolution;

AND FURTHER BE IT RESOLVED THAT if the offer is not accepted, the Chief Administrative Officer is authorized to retain a Manitoba land surveyor to prepare the necessary expropriation plan and to have the necessary documents and material prepared under the Expropriation Act providing for the expropriation of the lagoon expansion land.

- 6) That monument restoration costs, for monuments that were found to be restored within this subdivision, will be borne by the Developer;
- 7) That any and all costs associated with this Subdivision will be borne by the Developer.
